- That the school authority shall provide retirement benefits to the teaching and non-teaching staff of the school as per a Death Cum Retirement Benefit Scheme.
 - That the managing committee of the school shall be constituted with at least three guardian and one non-teaching staff. The Principal will be an members, three elected teacher members and one non-teaching staff. The Principal will be an Ex-officio member of the Managing Committee.
- That the school authority shall not enhance tuition fees or other charges without prior permission 5. (a)
 - That the school shall not charge any capitation fee or equivalent to capitation fee by any means.

That the recruitment of teachers shall be done in accordance with transparent, merit-based criteria, to be laid down in the Memorandum of Parent Body and information thereof shall be made

That the funds raised by the school authority, the fees collected and earned income by any ourse, shall not be utilized for any other purpose than the welfare of the school and benefit of the school.

That nothange in the ownership of the school or handing over of property or management of the school shall be done by any manner. Changing or amending the character of the Parent Body aball not be done without prior notice to the State Government.

That service of the teaching and non-teaching staff shall not be teaching and popular opportunity of being heard by the competent authority and authority an 9. opportunity of being heard by the competent authority and without observing due disciplinary proceedings. WEST BENGAL

That the service condition of the teaching and non-teaching staff including provisions of security of service, disciplinary proceedings and procedure for Appeal shall be implemented in accordance with the directions laid down in the Memorandum of the Parent Body and submitted to the State Government.
